#### What is the purpose of the Trust?

The Trust is dedicated to supporting individuals who have experienced harm or disadvantage as a result of involvement with religious cults or spiritual communities - particularly former Centrepoint residents & their children. In addition to this core focus, the Trust also provides assistance to organisations whose work aligns with the trust mission. It also offers scholarships to these individuals, helping them pursue opportunities for growth & development.

#### Am I eligible for the Therapeutic & Counselling / Budgeting funding criteria?

- > Past residents of Centrepoint & their children.
- > People disadvantaged by a system of religious worship or spiritual cult / community.

#### What funding is available?

- > Funding is available for up to two sessions per month, or a total of 24 sessions within a 12-month period (from 1 July to 30 June annually)
- > Sessions must be with a registered Therapeutic or Counselling provider or Budgeting provider.
- > The trust can only consider a maximum cost per session of \$150 (incl GST).

Each application can be approved for a maximum of six sessions at a time. If more sessions are needed, applicants are encouraged to submit a new application once they have attended session 4 onwards, to help ensure continuity of care. Invoices are paid directly to the provider.

For first time applicants to this trust, we kindly ask that you provide a cover email with your application with a brief background outlining how you have experienced disadvantage within the referred religious cult or spiritual community. Please only share information that you feel comfortable providing. This background is requested for initial applications only and is not required for future applications. This information will be held securely & confidentially.

#### What support can I obtain?

Counselling or therapeutic services providers must be registered with an appropriate professional body. The provider must comply with protocols and monitoring approved by such professional bodies who generally are:
